Commitment

The applicant - as owner or as a driver expressly authorised by the owner of the specified vehicle - is fully entitled to enter into this obligation and declares to take note of and accept the following provisions.

1. the ACS has undertaken on my behalf vis-à-vis the customs authorities and through the intermediary of its Corresponding Clubs, to pay the customs duties, fines, costs, etc., which may be required of the ACS by these authorities, based on the importation of the vehicle which is the subject of the customs document issued to me by the ACS or an association authorised by it.
2. consequently, I undertake
 - a) to re-import the specified vehicle into his country of registration during the period of validity of the customs document issued to me;
 - b) as long as the vehicle is abroad, not to let it be driven by any third party (except a chauffeur) domiciled in the country of residence, nor to lend, hire, pledge, sell or otherwise dispose of it;
 - c) to notify the ACS immediately in the event of loss of the customs document issued to me, theft, confiscation or accident, whether in Switzerland or abroad, and to assume all responsibility in the event of misuse of the customs document by third parties;
 - d) not to carry out or have carried out abroad any repairs to the vehicle declared, provided it is registered in Switzerland, without first notifying the ACS and obtaining permission from the Federal Directorate General of Customs to do so (cases of force majeure, such as sudden defects or accident, are excluded from this provision)
 - e) in the event of a change of domicile, to notify the ACS immediately;
 - f) to personally ensure the cancellation and timely return of the customs document issued to me before I sell the specified vehicle or make or have made a technical modification to it, or before I transfer my domicile to one of the countries for which the customs document issued to me is valid;
 - g) to take all measures ordered by ACS without delay for the cancellation and timely return of the customs document handed over to me;
 - h) to pay to the ACS all duties, fees and costs which have been or will be paid by the ACS for the cancellation of the customs document issued to me;
 - i) to return to the ACS at first request, but not later than the expiry date, the customs document which has been handed over to me;



- j) not to make or cause to be made, either himself or through any other person, any alteration to the customs document issued to me;
 - k) to choose as place of jurisdiction the seat of the central administration of the ACS and to accept the jurisdiction of that seat in all disputes directly or indirectly related to the customs document issued to me;
3. By this undertaking, to which I give the character of a general power of attorney, I authorise the ACS to take all actions and measures which it may deem necessary, either to avoid a customs claim or to obtain the cancellation of the customs document issued to me.
4. I certify:
- a) that neither I myself nor the owner of the vehicle have a domicile in the countries for which the customs document handed over to me is valid;
 - b) that the information given on the application is true and correct.
